1 FIRE DETAIL RATE: \$42.50/HR FOR EACH FIREFIGHTER

FIRE DETAILS ARE FOR FOUR (4) HOURS MINIMUM, PAYABLE IN ADVANCE OF ISSUANCE OF PERMIT.
ADDITIONAL TIME IS IN INCREMENTS OF FOUR (4) HOURS.

THE BALANCE ON FIRE DETAILS MUST BE PAID ON THE DAY OF THE DETAIL.2

2 DETAILS WHICH MUST BE INVOICED SHALL INCUR AN ADDITIONAL 10% ADMINISTRATION FEE.

3 FEE IS INCLUSIVE OF PERMIT & ONE (1) INSPECTION.
