To either of the Constables of the Town of Berlin in the County of Worcester:

Greetings: In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and in Town affairs, to meet at the Berlin Memorial School in said Berlin on Monday, the fifth day of May, 2014, next, at 7:30 o'clock in the evening, then and there to act on the following articles; or in relation thereto:

ARTICLE 1 – To see if the Town will vote to fill all vacancies and choose all necessary Town Officers, not required to be chosen by ballot, or take any action relative thereto.

I move that the Board of Selectmen, or any other Board having the proper authority, appoint all necessary Town Officers as may be provided for by statute or other authority and who are not required by law to be chosen by ballot.

ARTICLE 2 – To see what action the Town will take on the printed reports of the officers and committees of the Town for the year 2013; or take any action relative thereto.

I move that the various reports of officers and committees of the Town as contained in the annual town report be accepted by the Town, but without imposing any personal liability on any individuals who are officers of any board for the action taken hereby.

ARTICLE 3 – To see if the Town will vote to authorize the Treasurer, with the approval of the Selectmen, to borrow in anticipation of reimbursement to the Town by the Massachusetts Department of Transportation for the repair of roads and bridges; or take any action relative thereto. Finance Comm. recommends 4-0

I move to authorize the Treasurer, with the approval of the Selectmen, to borrow money in anticipation of reimbursement to the Town by the Massachusetts Department of Transportation for the repair of roads and bridges.

ARTICLE 4 – To see if the Town will vote to establish and authorize the use of revolving fund accounts, for FY2015, pursuant to the provisions of Mass. General Law Chapter 44, Section 53E1/2 for the purposes, maximum expenditure, and authority to expend as outlined in the table below. Expenditures shall not be made or liabilities incurred from any such revolving fund in excess of the balance of the fund or in excess of the total authorized expenditure. The authorized departments shall report to the Annual Town Meeting and the Board of Selectmen the total amount of receipts and expenditures for the prior fiscal year and the current fiscal year through December 31. Interest earned on any revolving funds shall be treated as general fund revenue of the Town; or take any action relative thereto. Finance Comm. recommends 4-0.

I move to establish revolving funds for Dog Licensing, the Library Trustees, the Cable Access Committee, the Assessors' Office, the Recreation Committee, and the Town Hall, for FY2015, as permitted under Chapter 44, Section 53E1/2 of the General Laws, with the stipulations as described in Article 4 of the warrant for this meeting.

ARTICLE 5 – To see if the Town will vote to authorize the Selectmen to expend from the Highway Department Expense budget, as enacted under Article 9, a sum not to exceed \$300.00 for insect and pest control and a sum not to exceed \$2,000.00 for Dutch Elm disease control, provided that the Tree Warden shall request the expenditure of such funds of the Selectmen; or take any action relative thereto. (Highway Dept.) Finance Comm. recommends 4-0.

I move to authorize the Selectmen to expend from the Highway Department Expense Budget, as enacted under Article 9, a sum not to exceed \$300.00 for insect and pest control and a sum not to exceed \$2,000.00 for Dutch Elm Disease control, provided that the Tree Warden shall request the expenditure of such funds of the Selectmen.

ARTICLE 6 – To see if the Town will vote to authorize payment of a salary of \$300.00 to each member of the Berlin School Committee as provided by Chapter 71, Section 52 of the General Laws; or take any action relative thereto. (Berlin School Committee) Finance Comm. recommends 4-0.

I move to authorize payment of a salary of \$300.00 to each member of the Berlin School Committee as provided by Chapter 71, Section 52 of the General Laws.

ARTICLE 7 – To see if the Town will vote to accept the provisions of Mass General Law Chapter 73, of the Acts of 1986 to grant additional real estate tax exemptions of 100% for fiscal year 2015 to persons who qualify for property tax exemptions under Clause 17D, 22, 22A, 22B, 22C, 22E, 37A, and 41C of Section 5 of Chapter 59; or take any action relative thereto. (Board of Assessors) Finance Comm. recommends 4-0.

I move to accept the provisions of Mass General Law Chapter 73, of the Acts of 1986 to grant additional real estate tax exemptions of 100% for fiscal year 2015 to persons who qualify for property tax exemptions under Clause 17D, 22, 22A, 22B, 22C, 22E, 37A and 41C of Section 5 of Chapter 59.

ARTICLE 8 – To hear and act on the reports of any outstanding committees, or take any action relative thereto.

ARTICLE 9 – To see if the Town will vote to raise and appropriate, or borrow, or transfer from available funds, or otherwise provide all necessary sums of money to defray the Town's expenses for the fiscal year beginning July 1, 2014 and to determine the salaries of the Town Officers for that period, or take any action relative thereto. The Finance Committee will recommend.

ARTICLE 10 – To see if the Town will vote to transfer a sum of money from the Anna Hunt Fund to the Library Account, and, further, to authorize the acceptance of any other monies from various sources, to the Library Account; or take any action relative thereto. (Library Trustees) Finance Comm. recommends 4-0.

ARTICLE 11 – To see if the Town will vote to accept a sum of money for Perpetual Care in the Cemeteries and a sum of money for the Cemetery Flower Fund; or take any action relative thereto. (Cemetery Comm.) Finance Comm. recommends 4-0.

ARTICLE 12 – To see if the Town will vote to appropriate the apportionment of Chapter 90 Transportation Bond Issue monies in the amount certified by the Commonwealth of Mass; or take any action relative thereto. (Highway Dept.) Finance Comm. recommends 4-0.

ARTICLE 13 - To see if the Town will vote to establish and authorize the use of a revolving fund accounts, for FY2015, for permitting software, pursuant to the provisions of Mass. General Law Chapter 44, Section 53E1/2 for the purposes, maximum expenditure, and authority to expend as outlined in the table below. ARTICLE 14 –To see if the Town will vote to accept the provisions of Mass. General Law Chapter 59, Section 57B, to issue Property Tax Bills not in excess of \$50.00 as a single bill, effective as of May 6, 2014 (Collector of Taxes). Finance Committee recommends 4-0.

ARTICLE 15 –To see if the Town will vote to raise and appropriate, borrow or transfer from available funds the sum of \$36,000 for the purpose of paving the Transfer Station service yard and any related expenses, or take any action relative thereto (Board of Health). Finance Comm. recommends 3-1.

ARTICLE 16 - To see if the town will vote to raise and appropriate , borrow ,or transfer from available funds the sum of \$218,000.00 to replace the 1999 combination truck with a 6 wheel combination, dump and sander truck ; or take any action relative thereto. (Highway Supt.) Finance Comm. recommends 4-0.

ARTICLE 17 - To see if the town will vote to raise and appropriate , borrow ,or transfer from available funds the sum of \$70,000.00 for the purchase of hot top ; or take any action relative thereto. (Highway Supt.) Finance Comm. recommends 4-0.

ARTICLE 24 – To see if the Town will vote to raise and appropriate, borrow or transfer from available funds the sum of \$6,500 for the purpose of repairing pavement in the parking lot at the Berlin Memorial School; or take any action relative thereto. (Berlin School Committee) Finance Comm. recommends 4-0.

ARTICLE 25 – To see if the Town will vote to raise and appropriate, borrow or transfer from available funds the sum of \$14,000 for the purpose of installing sound buffers in the cafeteria at the Berlin Memorial School; or take any action relative thereto. (Berlin School Committee) Finance Comm. recommends 4-0.

ARTICLE 26 – To see if the Town will vote to raise and appropriate, borrow or transfer from available funds the sum of \$16,000 for the purpose of replacing computers at the Berlin Memorial School; or take any action relative thereto. (Berlin School Committee) Finance Comm. recommends 4-0.

ARTICLE 27 – To see if the Town will vote to raise and appropriate, borrow, or transfer from available funds a sum not to exceed \$30,000 to be used for the study of the emergency service departments (Police, Fire, and Rescue), said sum to be expended by the Board of Selectmen, or take any action relative thereto. (Board of Selectmen) Finance Comm. recommends 4-0.

ARTICLE 28 - To see if the Town will vote to raise and appropriate, borrow or transfer from available funds, the sum of \$78,863 for energy efficiency building envelope repairs in the public safety building at 23 Linden Street, or take any action relative thereto. (Board of Selectmen) Finance Comm. recommends 4-0.

ARTICLE 29 – To see if the Town will vote to accept the provisions of Mass. General Law Chapter 59 Section 5K, property tax liability reduced in exchange for volunteer services; persons over age 60 (Senior Work-Off Program) with implementation in FY16, or take any action relative thereto. (Board of Selectmen) Finance Comm. recommends 4-0.

ARTICLE 30 – To see if the Town will vote to accept the provisions of Mass. General Law Chapter 59 Section 5N, property tax liability reduced in exchange for volunteer services; veterans. (Veteran Work-Off Program) with implementation in FY16, or take any action relative thereto. (Board of Selectmen) Finance Comm. recommends 4-0.

ARTICLE 31 - To see if the Town will vote to authorize the Board of Selectmen to enter into a Tax Agreement for payments-in-lieu-of-taxes ("PILOT") pursuant to M.G.L. Chapter 59, Section 38H(b), and Chapter 164, Section 1, or any other enabling authority, in the amount of \$_____ per megawatt and upon terms and conditions as the Board shall deem in the best interest of the Town, for both real property and personal property associated with a solar photovoltaic facility having a proposed nameplate capacity of approximately 3.8 megawatts and an approximately 21.4 acre parcel of privately-owned land (Assessor's 7, Block 35, Lot 2) upon which such facility is to be located, and to take all actions necessary to implement such agreement; or take any other action relative thereto. (Board of Selectmen) Finance Comm. made no recommendation on this article.

ARTICLE 32 - To see if the Town will vote to authorize the Tax Title Custodian to transfer the following parcels of tax title land:

- Lot referred to as "Unknown, Heirs of Wheeler", located off the westerly side of Crosby Road and shown on the Assessors Map 6 as Block 5, Lot 1
- Lot referred to as "Borges, Clement", located off the easterly side of (lower)Sawyer Hill Road and shown on the Assessors Map 21 as Block 22, Lot 0
- Lot referred to as "Unknown Bliss", located off the easterly side of (lower)Sawyer Hill Road and shown on the Assessors Map 21 as Block 29, Lot 0
- Lot referred to as "Unknown Sawyer", located off the westerly side of Lancaster Road and shown on the Assessors Map 23 as Block 4, Lot 0

- Lot referred to as "Unknown Sawyer", located off the westerly side of Lancaster Road and shown on the Assessors Map 23 as Block 5, Lot 0

from the care, custody and management of the Tax Title Custodian to the care, custody and control of the Berlin Conservation Commission for conservation purposes pursuant to G.L. c. 40, §8C and Article 97 to the Amendments of the Massachusetts Constitution and to authorize the Town Treasurer/Tax Title Custodian to execute and record deeds transferring said parcels to the Conservation Commission for conservation purposes, or taken any action relative thereto. (Treasurer/Cons. Comm.) Finance Comm. recommends 4-0.

ARTICLE 33 - To see if the Town will vote to transfer care, custody and control of a certain parcel of land, Registry Book 5046, Page, 268, Assessor's Map Page 19, Block 52 Lot 0, located off the westerly side of Lancaster Road, referred to as "Anchor Kinney" from the Town's Tax Title Custodian to the Board of Selectmen for general municipal purposes, including the purpose of conveyance, and further, to authorize the Board of Selectmen to convey said property upon such terms and conditions, including, without limitation, as part of a land exchange agreement, as the Board deems in the best interest of the Town and, further, to authorize the Board to accept, for general municipal purposes, such other land that the Board may acquire pursuant to said exchange agreement, or take any action relative thereto. (Treasurer) Finance Comm. recommends 4-0.

ARTICLE 34 -To see if the Town will vote to accept the provisions of G.L. c. 64L, § 2 authorizing the Town to impose a local sales tax at the statutory rate of 0.75 percent on the sale of restaurant meals originating within the Town, or take any action relative thereto. (Treasurer) Finance Committee had a split vote, with 2 in favor and 2 opposed.

ARTICLE 35 - To see if the Town will vote to accept the provisions of G.L. c. 64G, § 3A authorizing the Town to impose a local excise tax of 6% upon the transfer of occupancy of any room or rooms in a bed and breakfast establishment, hotel, lodging house or motel located within the Town by any operator; and further, to set such local excise, or take any action relative thereto. (Treasurer) Finance Comm. recommends 4-0.

ARTICLE 36 - To see if the Town will vote to amend the Town of Berlin General Bylaws, Article XIII, Regulation of Business, by deleting the current Section 1 in its entirety and replacing it with a new Section 1 to read as follows:

Section 1. Regulation of Junk and Secondhand Dealers

1. Definitions

Secondhand dealer - any person conducting the business of buying, obtaining, acquiring, receiving, selling, exchanging, dealing in or dealing with secondhand personal property (hereinafter also referred to as an "article"), including, but not limited to jewelry; diamonds; precious or semi-precious stones or gems; precious or semiprecious metals; watches; musical instruments and equipment; cameras; furs; figurines; home and motor vehicle stereo equipment; cellular phones; televisions; radios; video players and recorders; tools; computers and computer equipment; electronic devices and equipment; and motor vehicle accessories, but not including motor vehicles; second hand clothing other than furs; sporting goods; antiques, other than jewelry, watches, diamonds, precious or semi-precious stones or gems, precious or semiprecious metals and figurines, which are at least ten (10) years old; and articles which are part of an estate or administrative sale or an auction. The Board of Selectmen may add from the list of articles listed herein by regulation adopted pursuant to Chapter 140, Section 54 of the General Laws.

Junk dealer - any person conducting the business of buying, obtaining, acquiring, receiving, selling, exchanging, dealing in or dealing with junk. "Junk" includes, but is not limited to, used or scrap materials or salvage not otherwise included in the materials listed in the definition of secondhand or old metal dealer.

Old metal dealer - any person conducting the business of buying, obtaining, acquiring, receiving, selling, exchanging, dealing in or dealing with old metals.

Person - an individual, firm, partnership, corporation, business trust, estate, partnership association, two (2) or more persons having a joint or common interest, or any other legal or commercial entity.

2. License Requirements (Dealers and Shopkeepers)

- (a) All dealers in and keepers of shops for the purchase, sale or barter of secondhand articles, junk and/or old metals shall be licensed by the Board of Selectmen prior to engaging in said activity and shall comply with these bylaws and any rules and regulations promulgated by the Board of Selectmen.
- (b) Applications for new licenses and renewal licenses shall be made in writing to the Board of Selectmen, with a copy provided to the Berlin Police Department, on forms provided for this purpose by the Town. Each application shall state the specific place or location of business at which the licensed activity shall take place. Each license granted shall be issued on a location specific basis. No license shall be granted without a specific place of business which is in compliance with applicable zoning bylaws, however the grant of a license shall not be evidence or proof of zoning compliance.
- (c) Upon approval, a license shall be issued and shall continue in effect, unless sooner revoked by the Board of Selectmen, until January 1st of the next following year. No license may be transferred or assigned.
- (d) The license shall be clearly and prominently displayed in a suitable and conspicuous place within the shop.

3. Records of Purchases -Transaction Records

- (a) Every secondhand dealer, junk dealer and old metal dealer upon the acquisition, regardless of the manner of acquisition, of any article, good or item subject to licensing hereunder shall prepare a transaction record upon a form approved by the Board of Selectmen or its designee, stating:
 - i. The full name, current address, date of birth and driver's license number of the seller;
 - ii. The date and time of transaction;
 - iii. A full, detailed and accurate description of each article;
 - iv. The amount paid for each article, and;
 - v. The name of the employee or person receiving the item.
- (b) Each seller shall sign their name on the transaction record.
- (c) The secondhand dealer, junk dealer and old metal dealer shall attach a photograph of the seller, and the seller's identification, which shall be photo identification issued by a government agency (i.e. driver's license, liquor identification card, passport, etc.) to the transaction record.
- (d) All articles shall be photographed in reasonable detail. Said photograph shall accurately and clearly represent the article, and photos shall be attached to the transaction record.
- (e) Every secondhand dealer, junk dealer and old metal dealer shall maintain the original transaction record and all photographs for a minimum of three (3) years)
- (f) One clear copy of the previous week's transaction record and photographs shall be delivered to the Berlin Police Department by 12:00 noon every Monday, unless otherwise directed in writing by the Chief of Police. Copies of records and photographs may be submitted electronically.
- (g) All transaction records shall be open to inspection by the Chief of Police or any officer or person duly authorized by him, or any other person authorized under law.

4. Record of Purchases – Log

- (a) Every secondhand dealer, junk dealer and old metal dealer shall also record each transaction, with the information required pursuant to Section 3 in a bound book with consecutively numbered pages. The book shall be of a size and style approved by the Chief of Police or his designee. All entries shall be in ink, legible, written in English and assigned a number. The corresponding number shall be attached to the item. No entry in the book shall be erased, obliterated, altered or defaced.
- (b) The transaction book shall at all reasonable times be open to the inspection by the Chief of Police or any officer or person duly authorized by him, or any other person authorized under law. The transaction books shall be kept for a minimum of three (3) years after the secondhand dealer last does business in the Town of Berlin.

5. Notification to police

Secondhand article, junk and old metal dealers shall immediately notify the Berlin Police Department upon receiving an article which is questionable as to its status of being stolen or not, and shall make such article available for identification by an officer of the Police Department.

6. Receipt of articles from minors

No secondhand, junk or old metal dealer or any employee or agent of such a dealer shall directly or indirectly purchase or receive by way of barter or exchange any article secondhand articles, junk or old metals from a minor.

7. Holding period

(a) No article shall be sold, encumbered by sales contract, or otherwise disposed of, or altered in its appearance, within thirty (30) days of purchase, unless the dealer is granted permission, in writing, from the Chief of Police or his designee. With respect to any secondhand article for which permission is granted by the Chief of Police pursuant to this subparagraph, the person buying or otherwise receiving said article shall complete a transaction record upon a form approved by the Board of Selectmen or its designee which provides the information required pursuant to Section 3(a) above as applicable to a person buying or receiving a secondhand article.

(b) All articles purchased shall remain on the premises during the waiting period; items shall not be placed on the sales floor until the waiting period has expired, unless the item is clearly marked with the corresponding transaction number and the sales release date based on the time frame as specified in subparagraph (a), above.

(c) The following are exempt from the holding period requirement of this Section 7: auction purchases, estate purchases from an executor/executrix or administrator/administratrix where the purchase is accompanied by written proof of said position.

8. Examination of articles and shop

Any shop described or governed by Section 2 and all secondhand goods, old metals and/or junk therein may at all times be examined by a person authorized in writing by the Chief of Police to make such examination.

9. Removal of articles by police officers

(a) If the Berlin Police Department determines that a secondhand good, old metal or junk article(s) is needed for evidence in a criminal investigation, a Berlin Police officer may seize that evidence, subject to applicable criminal procedures, if any. The secondhand dealer, old metal dealer or junk dealer shall be issued a receipt for the article(s).

(b) The Berlin Police Department may keep seized articles, subject to a courts direction, if any, as long as necessary to permit the article to be used as evidence and for such reasonable time thereafter as needed to best determine, if possible, the person(s), if any, lawfully entitled to said property.

10. License Suspension and/or revocation

Any license issued under Article XIII Section 1 of the By-laws and governed by these rules and regulations may be suspended or revoked, after a hearing for cause or violation of these rules and regulations.

ARTICLE 37 - To see if the Town will vote to amend the Zoning By-Law by adding the following definition to Article 14:

Riding Stable

The commercial housing of three or more horses by means of rental of stalls and/or stables and/or the use of property for the purposes of horseback riding lessons, horse training and similar uses. It shall include any stable where horses are kept for hire to the general public and shall include, but not be limited to, guided and unguided riding or carriage driving

or take any action relative thereto. (Planning Board)

ARTICLE 38 - To see if the Town will vote to amend the Town of Berlin Zoning Bylaw Section 410 Flood Plain District by making the following changes:

- Section 412, delete the letter E from each panel number and replace it with the letter F and change the date to July 16, 2014;

- Section 413, delete the words "Flood Resistant Construction and Construction in Coastal Dunes" (Planning Board)

ARTICLE 39 - To see if the Town will vote to transfer from available funds a sum of money to be used toward the reduction of the 2014-2015 tax rate; or take any action relative thereto. (Fin. Comm.)

ARTICLE 40 -- To meet at the Berlin Town Offices, 23 Linden Street, lower level, in said Berlin on Monday, May 12, 2014, between the hours of 12:00 Noon and 8:00 p.m. to elect by ballot the following officers: Moderator for one year; Town Clerk for three years; Selectman for three years; Assessor for three years; Constable for three years; School Committee for three years; School Committee for two years; Assabet Valley Reg. Vocational District School Committee for four years; Trustee of Trust Funds for three years; Cemetery Commissioner for three years; Library Trustee for three years; Planning Board for five years; and Board of Health for three years. (Town Clerk)

And you are directed to serve this Warrant, by posting up attested copies thereof as per vote of the Town in said Town, seven days at least before the time of holding said meeting.

Hereof fail not, and make due return of this warrant, with your doings thereon, to the Town Clerk, at the time and place of meeting as aforesaid.
