In its petition dated & received October 14, 2022, Massachusetts Electric Company d/b/a National Grid has petitioned the Berlin, MA Select Board for permission to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way:

At 100 River Road West - National Grid is to install 1 Solely-Owned (SO) Pole on River Rd West beginning at a point approximately 0' feet northeast of the centerline of the intersection of South St Rotary and continuing approximately 1050' feet in a northeast direction. Install 1 SO Pole # 7-1 approximately 1050' northeast of South St Rotary. This pole is necessary to provide service at 100 River Road West. Location approximately as shown on the plan attached.

Massachusetts Electric Company d/b/a National Grid requests permission to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way:

River Rd West - National Grid to install 1 SO Pole on River Rd West beginning at a point approximately 0' feet northeast of the centerline of the intersection of South St Rotary and continuing approximately 1050' feet in a northeast direction. Install 1 SO Pole # 7-1 approximately 1050' northeast of South St Rotary.

Location approximately as shown on plan attached

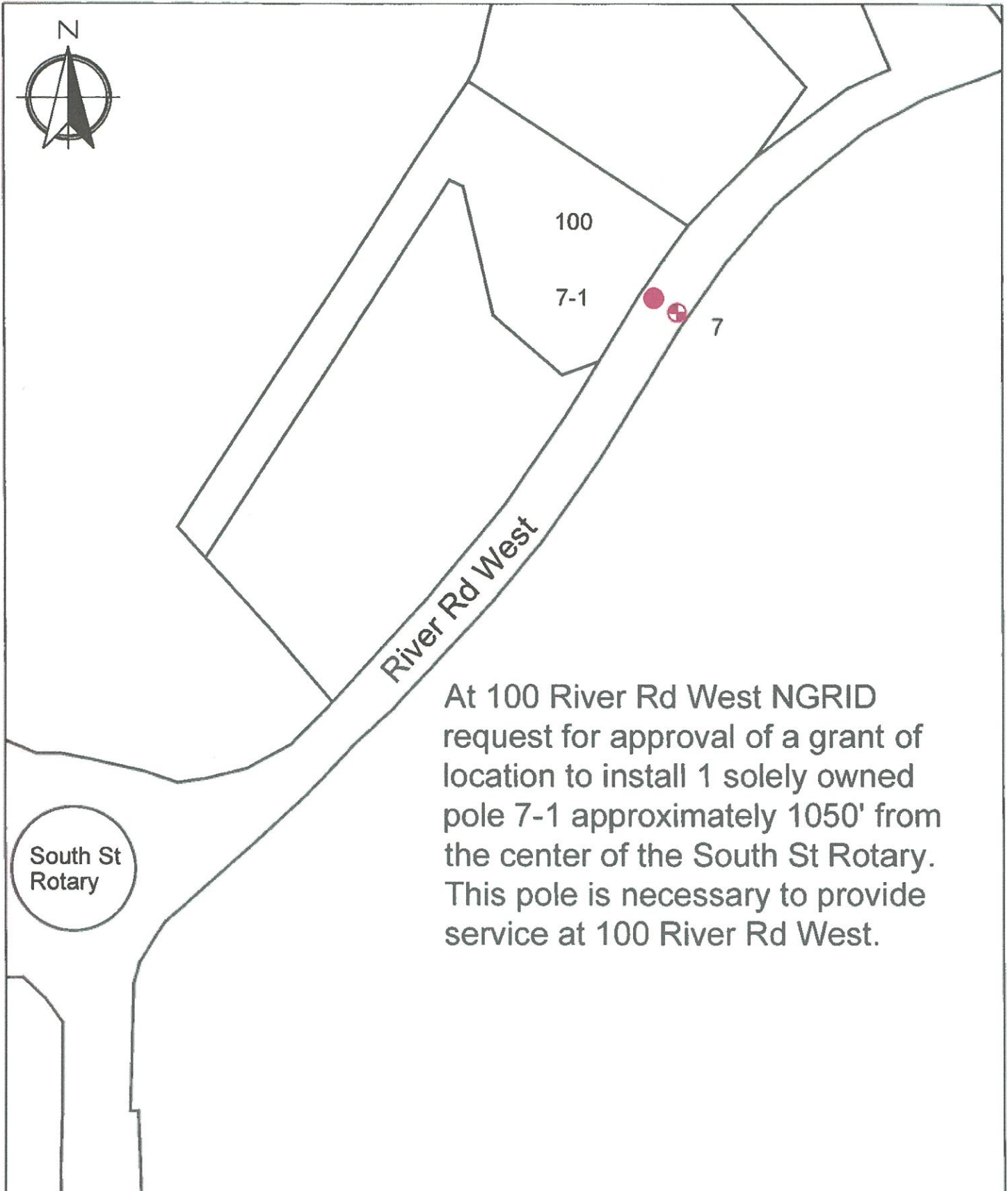
